WHY TSINGHUA

Tsinghua University's history began with its inception as "Tsing Hua Imperial College" in 1911. The faculty greatly valued the interaction between Chinese and Western cultures, the sciences and humanities, the ancient and modern. Tsinghua scholars Wang Guowei, Liang Qichao, Chen Yingue and Zhao Yuanren, renowned as the "Four Tutors" in the Institute of Chinese Classics, advocated this belief and had a profound impact on Tsinghua's later development.

Following the outbreak of the War of Resistance against Japanese Aggression in 1937, National Tsing Hua University, National Peking University and Nankai University merged to form the National South-West Associated University in 1938 after moving to Kunming.

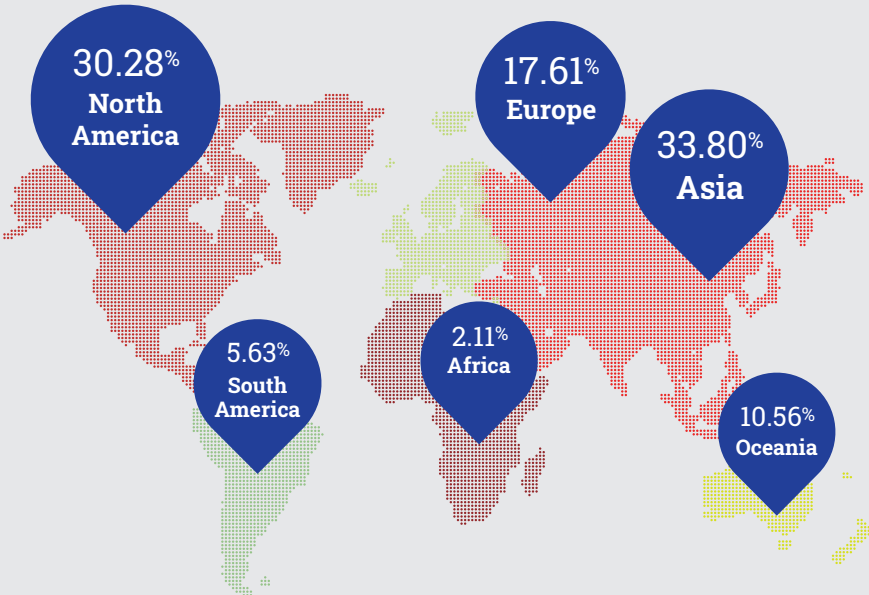
